What You Will Be Doing

Fellows in this program will have an opportunity to participate in a myriad of roles across science, medicine, business, strategy, operations and investing. The fellowship typically ranges from four to six months in our downtown Boston or Century City locations. Vida is flexible on the fellowship duration, with the potential for longer term opportunities.

Key Responsibilities:

- Participate as a member of Vida's core team in meeting companies and executive management teams, conducting due diligence and assisting in company-build activities.
 - Evaluate scientific evidence, clinical paradigms, IP and competitive/commercial landscapes.
- Contribute to internal investment review process to arrive at financing decisions.
- Screen business plans and investment proposals.
- Work on operational and strategic initiatives for current and potential portfolio companies.
- Generate new investment themes through primary and secondary research.

- Commit ~15-20 hours a week.
 - Requires flexibility to attend scheduled and ad-hoc meetings.
 - Preference to spend at least 1 day per week in the office, pending COVID-19 guidelines.
 - Open to remote applicants (not in Boston or LA).

- Educational Series led by Vida's management and network of industry veterans.
- Potential participation at conference events, alongside a full-time Vida member.
